The Association of Employment and Learning Providers supports this proposal as this will reduce the hurdles that providers have to "jump" through to have the handling of a complaint reviewed independently, this also ensures that there is no delay in complaints being considered by the Independent Complaints Adjudication Service for Ofsted (ICASO). The addition of a periodic review of closed complaints is also supported as this will support continuous improvement and highlight potential themes within complaints that may otherwise not be recognised.
